General Programs & Services

Massachusetts Business Resource Team (BRT)

Located at the Massachusetts Office of Business Development, BRT helps businesses access resources provided by BRT partners. Programs and services include financing, tax incentives, permit assistance, workforce development and technology collaborations. (www.mass.gov.com)

MassDevelopment

MassDevelopment structures financing packages for businesses, using development funds, tax-exempt bonds and a variety of loan and guarantee programs. (www.massdevelopment.com)

MassBusiness

Work Opportunity Tax Credit (WOTC)

WOTC incents employers to hire from nine targeted groups of job seekers. Credits range from \$1,200 to \$9,000 for each new qualified employee. (www.mass.gov)

Adult and Community Learning Services (ACLS)

ACLS oversees no-cost basic educational services for adults in Massachusetts. (www.doe.mass.edu/acls)

Manufacturing, Equipment & Exports

Economic Stabilization Trust (EST)

EST lends working capital, term loans and lines of credit to small and medium sized manufacturing businesses in Massachusetts, providing loans when traditional financing is not available. (www.commcorp.org/trust)

MassBusiness Capital Access Program (CAP)

CAP helps businesses qualify for equipment loans up to \$500,000 by extending cash collateral guarantees. (www.mass-business.com)

Loan Guarantees & Insurance for Export Firms

Tax Credits & Incentives

Economic Development Incentive Program (EDIP)

EDIP provides participating companies with state and local tax incentives in exchange for job creation and private investment commitments. (www.mass.gov)

The Massachusetts Investment Tax Credit (ITC)

ITC offers qualifying businesses a three-percent credit against their Massachusetts corporate excise tax. The credit is to be applied toward the purchase and lease of qualified property used in the course of doing business. (www.mass.gov)

Incentives for Bio-Technology Companies & Medical Device Manufacturers

This programs rewards eligible companies in these fast-growing sectors with incentive payments for creating new jobs. (www.mass.gov)

Research & Development Tax Credit

Massachusetts offers manufacturers and R&D companies a tax incentive for research and development investment. (www.mass.gov)

Single Sales Factor

Massachusetts' Single Sales Factor, compared with the Three-Factor formula used in many states, helps create an attractive tax environment for businesses. (www.mass.gov)

Tax Increment Financing (TIF)

Massachusetts' version of Tax Increment Financing allows municipalities to provide flexible, targeted incentives to stimulate job creation. (www.mass.gov)
